Sub: Renewal of fire safety certificate of existing school building.

This is reference to your application no.0176182218000091 dated 17-08-2023 regarding the Renewal of Fire Safety Certificate of existing G+3 storied (1 block) and G floor (2 block) school building.

The performance of the Fire Fighting System as Incorporated in the buildings were tested at random and found satisfactorily working condition. In view of the above this office is releasing the Renewal of Fire Safety Certificate for occupancy of the aforesaid building.

However to up-keep the Fire Safety Measure of the aforesaid building the following safety measures need to be incorporated/maintained .

**Recommendation:**

- 1) Regular checking , testing and maintenance of the fire safety installation by a licensed Agency/Expert is must.
- 2) Good housekeeping to be maintained.
- 3) Regular checking and maintenance of electrical wiring and installation by a licensed Electricians is must.
- 4) Regular mock fire drill and evacuation drill should be conducted by participation of all and for this purpose , a special crew should be formed.
- 5) Certificate shall have to be obtained from this Office about the satisfactory performances off all fire and life safety installations failing which the Fire Safety Certificate shall be revoked as per rule 18 of the W.B fire Service (Fire Prevention & Fire Safety) Rules, 2003.

6) Building height or floor area or occupancy shall not be allowed to change without the approval of this document.

No. 629-L.—17th April, 2018.—The following Act of the West Bengal Legislature, having been assented to by the Governor, is hereby published for general information:—

## West Bengal Act XI of 2018

### THE WEST BENGAL FIRE SERVICES (AMENDMENT) ACT, 2018.

[Passed by the West Bengal Legislature.]

[Assent of the Governor was first published in the *Kolkata Gazette*,  
*Extraordinary*, of the 17th April, 2018.]

*An Act to amend the West Bengal Fire Services Act, 1950.*

WHEREAS it is expedient to amend the West Bengal Fire Services Act, 1950, for the purposes and in the manner hereinafter appearing;

West Ben. Act  
XVIII of 1950.

It is hereby enacted in the Sixty-ninth Year of the Republic of India, by the Legislature of West Bengal, as follows:—

Short title and  
commencement.

1. (1) This Act may be called the West Bengal Fire Services (Amendment) Act, 2018.

(2) It shall come into force on such date as the State Government may, by notification in the *Official Gazette*, appoint.

2. After sub-section (3) of section 11C of the West Bengal Fire Services Act, 1950, the following sub-sections shall be inserted:—

“(3A) A ‘Fire Safety Certificate’ issued under sub-section (2), shall remain valid for a period of three years with effect from the date of issue of such ‘Fire Safety Certificate’.

(3B) The owner or occupier of the high-risk building or any authorised person, as the case may be, shall submit an application for renewal of ‘Fire Safety Certificate’ in such manner, and on payment of such fees, as may be prescribed.”.
